Established in 2016, SVCU is proud to offer the My Community Matters Grant(s). This grant will be available through an application process to local groups or organizations, looking to develop/improve new or existing programs and/or facilities; that support education, health and wellness and/or the economic development of the valley and surrounding communities.

A total of \$20,000 is available through the My Community Matters Grant. The number of successful recipients and the grant amount awarded will be determined by the Grant Evaluation Committee.

### APPLICATION CRITERIA

Requests for funding must fall under one or more of the following 3 categories:

- 1. Youth Development through Education or Community based Sports Programs;
- 2. Community and Economic Development;
- 3. Health & Wellness Initiatives, Education or Service Programs.

#### Applicants must meet the following criteria:

- 1. All projects or programs must be within the valley or surrounding communities.
- 2. Requests for individuals will not be considered.
- 3. Funds may not be used for administrative or annual operating costs. Capital expenses, equipment and programming resources are allowed.
- 4. An organization or group may be funded more than one time, however a project will only be funded once.
- 5. Successful grant recipients are required to complete and submit the attached Grant Report upon the completion of their project or procurement of their capital purchase(s).

#### HOW TO APPLY

Interested groups and/or organizations can pick up a formal application from the Front Reception Desk at SVCU's main branch, located at 913 Main Street Swan River or download an application off of our website at <a href="https://www.svcu.mb.ca">www.svcu.mb.ca</a>.

The deadline for applications is March 6th, 2026. Completed applications are to be submitted to SVCU's main branch location at 913 Main Street Swan River or emailed to the attention of Roxanne Schneider, Chief Operations Officer. Please ensure that all requested and relevant information is included. Incomplete applications will not be considered.

The Grant recipients will be named on April 3rd, 2026, cheque presentations will take place at our AGM on April 13th, 2026.
